OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. MANY WILL ENTER; ONE WILL WIN.

1. ELIGIBILITY: The Tanger Outlet Centers®-Retailer Back to School Sweepstakes (this “Sweepstakes”) is open only to legal residents of the fifty (50) United States excluding Rhode Island and the District of Columbia who are at least eighteen (18) years old or the age of majority in their state of residence at the time of entry. Residents of the state of Rhode Island are not eligible to participate. Employees of Sponsor, Tanger Properties Limited Partnership (D/B/A Tanger Outlet Centers) and their immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible to enter or win. Sponsor sometimes excludes winners of its sweepstakes from winning another sweepstakes sponsored by Sponsor for 12-months thereafter; if applicable, prior winners in sweepstakes offered by Sponsor within the 12-month period applicable to them are also excluded from this Sweepstakes.

This Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited or restricted by law. Participation constitutes each entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions, which are final and binding in all matters related to the Sweepstakes. 3. SWEEPSTAKES PERIOD: This Sweepstakes begins at 9:00 A.M. local time on July 6, 2022 and ends at 9:00 P.M. local time on July 12, 2022 (the “Sweepstakes Period”). Sponsor’s time-keeping device is the official time-keeping device for this Sweepstakes.

4. HOW TO ENTER: To enter the Sweepstakes visit Tangeroutlets.com where the entry form will be housed for a chance to win. Entrant will fill out their name, address, email and phone number with opt-ins. The workings of this Sweepstakes will be tracked through a Sponsor platform. Entrant may also earn an extra entry by becoming a TangerClub member or currently being a TangerClub member.

Sponsor will only accept entries during the Sweepstakes Period. An Entrant may enter the Sweepstakes only one (1) time during the Sweepstakes Period. Entrants are subject to all notices posted online including, but not limited to, Sponsor’s Privacy Policy.

The Sweepstakes platform does not support multiple entries from the same IP address. Any attempt to enter the Sweepstakes by using multiple/different identities, registrations and logins, addresses, or any other methods will result in disqualification. Potential winners will be required to show an appropriate and generally accepted form of identification.

Sponsor reserves the right, in its sole and absolute discretion, to reject, disqualify and/or remove any entry without prior notice to the Entrant if, in Sponsor’s sole opinion, the entry violates these Official Rules or the spirit of the Sweepstakes.

ALL POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR OR ADMINISTRATOR, WHOSE DECISIONS ARE FINAL.

5. METHOD OF DETERMINING WINNER:

One (1) Winner will be selected randomly, through Sponsor's platform from among all entries properly and timely received, on or about July 12, 2022. An individual who wins under any other Tanger giveaway or sweepstakes sponsored by Tanger Outlets during the 12 months prior to this Sweepstakes shall not be eligible to win this Sweepstakes. Winners of this Sweepstakes shall not be eligible to win any prize under any other sweepstakes sponsored by Tanger Outlets for the twelve (12) month period immediately following this Sweepstakes Period.

Duplicate, incomplete, mechanically reproduced, or apparent fraudulent entries may be disqualified within Sponsor's sole discretion.

Winner will be contacted via email and will be directed on further required steps. If a winner fails to respond within forty-eight (48) hours of Sponsor's email notification notifying the potential winner, or the Sponsor's email is not accepted or delivered for any reason, that winner will be deemed to have forfeited the prize, and Sponsor may select a substitute winner by random drawing from all remaining eligible entries. Sponsor shall have no liability whatsoever for any winner notification that is lost, intercepted, misdirected, or not received by the potential winner for any reason. Entrant shall be solely responsible for checking their email account on a regular basis to verify whether their entry has been selected as a potential winner. Sponsor's decisions are final and binding in all respects.

6. PRIZE: Sponsor will award One (1) Grand Prize. One (1) winner will receive:

One (1) Old Navy Gift Card in the amount of one hundred dollars (\$800.00) (Total Approximate Retail Value: \$800, total value of prize \$800).

Prize will be mailed to winner. Sponsor reserves the right to verify prize claimant.

Winner is solely responsible for all federal, state, and local taxes and other fees associated with prize receipt and/or use as well as all sales tax and gratuities. No substitution, assignment, re-sale, or transfer of prizes permitted, except by Sponsor, who reserves the right to substitute a prize with another prize of greater or equal value. A winner of any prize may choose not to accept the prize in their discretion, in which case Sponsor will select a substitute winner through a random drawing of all properly and timely received entries. Unclaimed prizes may not be awarded.

7. WINNER NOTIFICATION: Winner will be notified by email. If a potential prize winner does not respond to Sponsor within the required time, such potential winner may be disqualified, and an alternate winner will be selected by random drawing. A potential prize winner will receive an Affidavit of Eligibility, Liability & Publicity Release (the "Releases"), which must be completed in its entirety and returned to Sponsor prior to the potential winner claiming their prize. A potential Winner will not be confirmed as the Official Winner until the Releases are completed and returned to Sponsor pursuant to these Official Rules. A winner may waive their right to receive a prize. Sponsor will report prize value to the IRS and will issue the winner IRS Form 1099. Sponsor may require winner to sign an affidavit or IRS Form W-9 to claim the prize.

Non-winning Entrants will not be notified.

8. PRIZE CONDITIONS AND LIMITATIONS: If the Releases are returned as undeliverable, not completed and returned in a timely manner, or if the selected winner cannot accept or receive the prize for any reason, or they are not in compliance with these Official Rules, the prize will be forfeited, and an alternate winner will be selected.
