OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

SWEEPSTAKES PERIOD: Tanger Outlet Center's What's Your #TangerStyle? Outfit Game (the "Sweepstakes") begins at 9:00 A.M. (local time) on July 19, 2019 and ends at 9:00 P.M. (local time) on August 25, 2019 (the "Sweepstakes Period").

ELIGIBILITY: The Sweepstakes is open only to individual legal residents of the fifty (50) United States, the District of Columbia, and the province of Ontario, Canada who are at the age of majority at the time of entry. Void outside these geographic areas and wherever else prohibited by law. All "TangerStyle" outfits properly and timely entered into the Sweepstakes will be housed in a gallery posted on the Tanger Outlets website. Entrants and members of the general public may vote on their favorite outfit one (1) time per calendar day during the Sweepstakes Period. Entrants may vote on their own outfit/ entry. At the end of the Sweepstakes Period eleven (11) prizes will be awarded based upon the eleven (11) "TangerStyle" outfits which received the most votes. An Entrant may only win once. Any individual, whether or not an Entrant, who attempts to circumvent these Rules or vote more than one (1) time per calendar day shall be disqualified and/or have all of his/her votes nullified.

Winners will be notified by Sponsor via email address set forth on the entry form. Sponsor shall have no liability whatsoever for any winner notification that is lost, intercepted, misdirected or not received by the potential winner for any reason. Sponsor's decisions are final and binding in all respects.

If a prize winner is a resident of Canada, per Canadian law the winner will be required to correctly answer a time-limited, skill testing question without any personal or mechanical device assistance in order to be eligible to receive his/her prize. GRAND PRIZE:

One (1) Grand Prize: One (1) Tanger Outlets Gift Card in the amount of two thousand five hundred dollars (\$ 2500.00 USD) shall be awarded to the one (1) individual Entrant whose "TangerStyle" outfit receives the most votes during the Sweepstakes Period.

Limit one (1) prize per winner.

A Winner must claim his/her prize in person during normal business hours at the Tanger Outlet Center of their choice within the United States or Canada. Winner is solely responsible for his/her own transportation
